  - 5 envelopes with a return address and postage (\$2 each)

### **Interview Arrangement :**

All applications will be entertained by the school and interviews will be held on 7<sup>th</sup> November, 2020 (Sat) in small groups and/or individually. Parents need to

accompany their child for the interview. Further details will be distributed via post. If no information has been received on or before 30<sup>th</sup> October, 2020 (Fri), please inform our school (2795 1008).

### **Acceptance Criteria :**

- i) Interview performance.
- ii) Priority will be given to applicants with siblings who have graduated or are currently enrolled at the school.
- iii) Priority will be given to applicants with familial needs for whole day classes. (Due to limited spaces, acceptance is not guaranteed.)

### **Admission Results :**

The school will inform parents of results on or before 18<sup>th</sup> December, 2020 (Fri) via post.

### **Notes on Registration :**

- i) Accepted Applicants :  
Parents will need to register in person during the “Centralised Registration Dates” (7<sup>th</sup> January, 2021 – 9<sup>th</sup> January, 2021) at our kindergarten and submit the original copy of the “Registration Certificate for Kindergarten Admission” along with the registration fee.
- ii) Waitlisted Applicants :  
Should accepted applicants choose to give up their placement, waitlisted applicants will be informed individually to register at our kindergarten on specified dates, and will need to submit the original copy of the “Registration Certificate for Kindergarten Admission” along with the registration fee.
- iii) Should registration not be completed, or should registration documents fail to meet the requirements, parents will need to apply for a registration certificate with the Education Bureau within a designated time period.
- iv) The registration fee for the academic year of 2021/22 is \$970 (half day class) / \$1,570 (whole day class). This fee will be refunded during the first month of school (October 2021) should the applicant choose to enroll. If parents decide to transfer schools after registration, the school will require notification in writing. The school will return the registration certificate, but the registration fee will not be refunded. Our school will no longer hold placement for the applicant and waitlisted applicants will fill the vacancy.

### **Notes:**

- i) The Education Bureau began the “Free Quality Kindergarten Education Scheme” in 2017/18. The official

registration document will be the “Registration Certificate for Kindergarten Admission”.

- ii) Parents need to apply for the “Registration Certificate for Kindergarten Admission” **during September-November, 2020**.
- iii) Applications for the “Registration Certificate for Kindergarten Admission” will begin in September, 2020. EDB will announce details through their website: <http://www.edb.gov.hk/>
